

## 2024 PROPERTY TAX COLLECTION during Dec 2024 to Jan 2025

### General Information:

- I will accept tax payments for real estate and property taxes between now and January 31, 2025.
- **I will NOT accept cash, credit card or electronic payments.**
- After January 31, 2025, ALL payments must be made payable & sent to: Monroe County Treasurer.
- All *first* installments and personal property payments are due by 1/31/25. You may pay your taxes in full. I will accept postmarks.
- Make ALL checks payable to **TOWN OF LA GRANGE** (between December 2024 – January 31, 2025).  
\*\*This includes payment of taxes **AND** dog licenses.
- Please include your phone number on checks so that I may contact you if there are issues with the payment.

### Unacceptable Payment Options:

I will **NOT** accept payments in person at my home under any circumstances. **Mail payments or stop in during office hours.** Thank you.

Dog Licenses	I will be accepting payment for dog licenses as well. Proof of current rabies vaccine is REQUIRED. Include a self-addressed, stamped envelope so I may mail you the dog tag. <u>If you pay in December</u> , please send a separate check for the dog license fee(s). No CASH or CREDIT.
Receipts for mailed payments	If you want a receipt, you MUST include a self-addressed, stamped envelope with your payment. If paid by a lender or through escrow, mail me a self-addressed, stamped envelope and a note asking for a receipt.
Tax Roll/Booklets for mailed payments	If you would like a copy of the tax booklet, you must provide a self-addressed, stamped, BUSINESS size envelope. We will also make it available on our website.

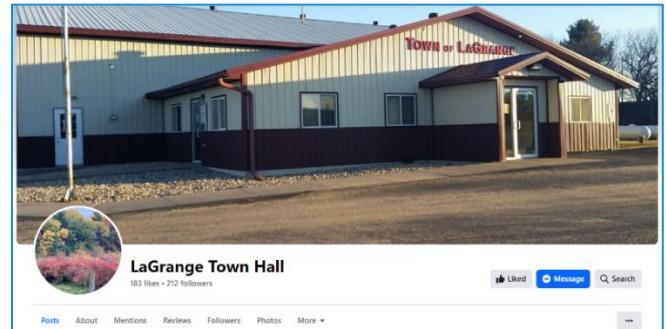

## Right-Of-Way Clearance Notification:

We would like to make LaGrange residents aware of an upcoming multi-year project to clear rights-of-way on town roads. Vegetation has encroached on our Town roads, causing problems over the winter months when roads often remain icy due to a lack of direct sunlight. Additionally, larger vehicles like school buses are regularly hit by overhanging branches. To resolve this, we will be pushing back vegetation to the edge of the right-of-way which, in most cases, is 33' from the roadway centerline. Advanced notice will be given prior to cutting, but if you have questions about this initiative—or anything else—please join us at our monthly Board Meetings which are held on the second Monday of each month, 7pm, at the Town Hall.

## Information on Recycle Center Rules and Policies

- The Town of LaGrange Recycle Center is available for Town residents only; if you know of non-Town residents using the facility, please notify the recycle center attendant.
- The recycle center is for residential waste disposal only—no commercial/farm waste is authorized.
- Cardboard boxes going into the recycle compactor should be fully broken down.
- The large brush pile is for tree waste only—do not put construction materials like lumber into the pile.
- The compost pile is for clean yard waste only. Leaf bags, flower pots, or any other non-organic materials should not be placed in this pile.
- Clean waste oil is accepted at the Recycle Center. Paint, antifreeze, or other hazardous chemicals like weed killers are not accepted.
- NOTE: Failure to comply with these rules can result in DNR fines and potential shutdown of the Recycle Center.
